#### A letter from the President Common Sense Trail Riding

You all read about the horse incident at Schick recently, where a rider rode across a field that was seeded. The farmer was understandably upset.
Well, the latest is that we have no idea who did it and we probably never will.
My biggest worry is that if we don't find the person, and educate them as to the rules, that it just might happen again. That's where you come in.
Each one of us should take it upon ourselves to spread the word. Talk to your riding friends and neighbors about what went wrong and what the rider

should have done. Now you ask, "What should the rider have done?"

Let me clear up the rules for everyone. If you ride at Schick, you are permitted to ride the mowed perimeter of the fields. The County now requires the farmer to mow the perimeter for just that purpose. In fact, the farmer at Schick told us that he has lost 14 acres worth of crop land in order to comply. So now imagine how he feels when some rider goes across a field instead of using the mowed perimeter! Bottom line is that if you are on a field and it's not the mowed edge, you are not permitted to be there, regardless of what time of the year. Although these are the rules, these are also common sense practices that you should use whenever you ride on any property. Always stay to the edge of any field. While in the woods, if you stick to the areas marked with ribbons, you will be on the designated trail.

In the fall, we plan to hire a contractor to clear the trails marked with ribbon, as part of the grant we received. After that work is completed, we will have an official trail at Schick, hopefully with signs informing people of the rules. Please remember, if you have any questions you can always contact one of us. We would be happy to go over the rules and regulations with you, so that we all can enjoy this treasure for years to come.

#### 25 MPH Sign Project

*Towards the end of last year the AEA* approached the Alexandria township committee about installing 25 mph Horse and Rider signs throughout the township, similar to the signs that the Pittstown Trail Association posted on Cooks Cross Road. The township committee is supportive and is willing to install the signs. The township will provide the posts and installation manpower and the AEA must provide the signs. The signs cost approximately \$95.00 per set. To that end we approached local businesses that we frequent, i.e. veterinarians, feed suppliers, tack shops etc. and asked them to sponsor a sign. Thus far we have received two sponsorships from Bob Moore and his neighbors on Wolf Road, and from John and Maxine Alexis. We have pledges from Larry Campbell, Katie Wigness/Larry Shepherd, Dr. Susan Smith, and Pete and Judy Tucker for four more signs.

It is our initiative to get two signs on each of the following roads: Rick Road, Wolf Road, Hickory Corner Road, Goritz Road, Stamets Road, Gallmier Road,

School House Road and Senator Stout Road - basically, the most heavily traveled roads in the township. The idea behind these locations was not to post signs at actual horse crossings (since those roads are often the less-used roads and therefore less visible locations) but, rather, to use the signs as educational advertisements of the 25 MPH law. *Many of us riders have been victim to* drivers speeding past us at 50 MPH, waving cheerily as they do so ignorance is bliss! We also approached Hunterdon County about posting signs on county roads around the township, but the county engineer felt that they were not suitable for county roads.
