

RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT

Name of Insured: **Alexandria Township & The Alexandria Equestrian Association**

Name of Location of Event: **Alexandria Township Park**

Under New Jersey Law, an Equestrian Area Operator is not liable for an injury to or the death of a participant in equine animal activities resulting from the inherent risks of equine animal activities, pursuant to P.L.1997, c.287, C:S:IS-1 ET SEQ.

In consideration of being permitted to ride in the Alexandria Township Park indoor/outdoor arenas, **EACH OF THE UNDERSIGNED**, for himself, his personal representatives, heirs, and next of kin, acknowledges, agrees and represents that he has, or will immediately upon entering arenas, and will continuously thereafter, inspect such Alexandria Township Park property which he enters and with which he comes in contact, and further warrants that his entry upon such arenas and his participation, if any, constitutes an acknowledgement that he has inspected such arenas and that he finds and accepts the same as being safe and reasonably suited for the purposes of his use, and he further agrees and warrants that if, at any time, he is in or about Alexandria Township areas and he feels anything to be unsafe, he will immediately advise the officials of such and will leave the park:

1. **The Undersigned hereby releases, Waives, discharges and covenants not to sue** the participants, sanctioning organization or any subdivision thereof, equestrian association, arena operators or owners, officials, volunteers, promoters, sponsors, advertisers, owners and lessees of premises used to conduct the event and each of them, their officers, volunteers and employees, all for the purposes herein referred to as "releases", from all liability to the undersigned, his personal representatives, assigns, heirs, and next of kin for any and all loss or damage, and any claim or demands therefore on account of injury to the person or property or resulting in death of the undersigned, whether caused by the negligence of the releases or otherwise while the Undersigned is in or upon the Alexandria Township Park property and/or competing, officiating in, observing, working for, or for any purpose:

2. **The Undersigned hereby agrees to indemnify and save and hold harmless** the releases and each of them from any loss, liability, damage, or cost they may incur due to the presence of the Undersigned in or upon the Alexandria Township Park property or in any way riding, competing, officiating, observing, or working for, or for any purpose participation in the event and whether caused by the negligence of the releases or otherwise.

3. **The Undersigned hereby assumes full responsibility for and risk of bodily injury, death or property damage** due to the negligence of releases or otherwise while in or upon the Alexandria Township Park property and/or while riding, competing officiating, observing, or working for or for any purpose participation in the event.

Each of the undersigned expressly acknowledges and equine activities are very dangerous and involve the risk of serious injury and/or death and/or property damage. **Each of the undersigned** further expressly agrees that the foregoing release, waiver, and indemnity agreement is intended to be as broad and inclusive as is permitted by the law of the State of New Jersey and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs the release and waiver of liability and indemnity agreement. and further agrees that no oral representations, statements or inducements apart from the foregoing written agreement have been made.

I have read this Release and Waiver of Liability and Indemnity Agreement. I understand it is a release of all claims.

I understand that I assume all risk inherent in equine activities within the Alexandria Township Park arenas (indoor and outdoor).

I voluntarily sign my name evidencing my acceptance of the terms stated on this page in connection with all Alexandria Equestrian Association events held during the 2018 calendar year, effective January 1, 2018.
